

**REQUIRED APPLICATION DOCUMENTS
FOR INTERNATIONAL F-1 VISA STUDENTS**

Thank you for your interest in attending Northampton Community College. Any student who is or intends to be in the United States with an F-1 student visa is considered an international student. In order for us to prepare your SEVIS Form I-20, which is required when you apply for your student visa, you must submit the following application documents:

1. Submit your application

Apply online at <https://www.northampton.edu/internationalapply>

2. Upload your passport to Dropbox: We must verify personal information for your SEVIS Form I-20.

3. Submit proof of financial support to Dropbox

You must prove that you have at least \$29,176.00 readily available for educational expenses. Acceptable sources of funding include checking accounts, saving accounts, or money market accounts.

- a. Complete and submit the enclosed Certification of Finance form.
- b. Submit bank letters or bank statements to verify funds indicated on Certification of Finance.

4. Pay non-refundable \$300.00 application deposit: a) To pay from outside the United States, pay online using [Flywire](#), or b) To pay from inside the United States, pay online using [Cashnet](#) and select "International".

5. Complete placement exams or submit proof of English proficiency: All F-1 visa applicants must complete this before receiving a Form I-20. See details [here](#) under "Placement Exams or English Proficiency".
