

## Sample Bequest Language

The Northampton County Community College Foundation gratefully accepts gifts for the benefit of Northampton Community College, whether made outright, in trust, or by bequest. We encourage you to use the sample language provided below when you create a bequest for the Foundation. Also, while it is not required, we ask that you send us a copy of that portion of your will naming the Foundation as beneficiary. This serves three purposes: first, it insures that the Foundation will be able to use your bequest as you intend; second, it allows the Foundation to plan its future with greater confidence, and third, when you provide the Foundation with a copy of your bequest, it qualifies you for membership in the *Foundation's Heritage Society*. *The following are suggested forms for bequests that may be used by testator or lawyer when writing a bequest to the Northampton Community College Foundation.*

### Unrestricted Bequests

I give and bequeath unto Northampton County Area Community College Foundation, a Pennsylvania corporation located at 3835 Green Pond Road, Bethlehem, PA 18020,

- a. the sum of \_\_\_\_\_ dollars.
- b. \_\_\_\_\_ percent (\_\_\_\_%) of my residuary estate.
- c. all of my residuary estate.

As an unrestricted gift,

- a. the principal and any income of which is to be used at the discretion of the Northampton Community College Foundation Board.
- b. which sum shall be added to the general unrestricted permanent endowment funds of the Northampton Community College Foundation so that the income derived therefrom may be used at the discretion of the Northampton Community College Foundation Board.

### Bequests for a Designated Purpose

I give and bequeath unto the Northampton County Area Community College Foundation, a Pennsylvania corporation located at 3835 Green Pond Road, Bethlehem, PA 18020,

- a. the sum of \_\_\_\_\_ dollars.

As a designated gift,
