

Requirements for Enrollment

Must be completed before the first class. All fees are the responsibility of the student.

- PA State nursing license. If your license is inactive, please contact the State Board of Nursing at (717) 783-7142 or www.dos.state.pa.us/nurse. If you have an out of state or country license, please contact the board of nursing of the state/country the license was issued in for requirements for PA licensure.
- Please complete a Pennsylvania Criminal Background Check, FBI Clearance and Child Abuse Clearance. You must also complete a signed Felony Disclosure form.
- Proof of malpractice insurance. If needed, please contact Nurses Service Organization at www.nso.com or 1-800-247-1500 or another malpractice insurance provider.
- Proof of personal health insurance. For those not currently enrolled in a healthcare plan, you may obtain shortterm, personal health insurance. For more information, please visit www.northampton.edu/studentinsurance.
- Current BLS certification. If you require certification, please visit www.northampton.edu/Healthcare click on BLS/ CPR/First Aid link on the left and select Basic Life Support.
- Completed NCC Health Form (including physical exam, immunization records, titers, TB testing (first step only), influenza vaccination, COVID-19 vaccination proof and medical clearance to get fit tested.)
- Uniform: solid navy blue uniform, uniform shoes or white leather/vinyl sneakers & stethoscope. (Required for clinical)
